



AN INVITATION TO PARTICIPATE IN THE PROVISION CORPORATION COLLECTIVE

One of our certified consultants has recommended your organization for acceptance into our collective of businesses as an Associate. To be an Associate is free of any cost or risk whatsoever.

Provision Corporation -- has formed a Collective of businesses for the sole purpose of using the collectivity of all its Associates as an inducement for the service providers and experts retained, to help our Associates become more competitive in these challenging economic times.

The Collective has been organized solely for the welfare of its Associates. It is not used for any political purposes or around any belief other than providing the many advantages that can come from joining hands as a collectivity of commercial enterprises to the advantage of each individual Associate.

The Invitation Is Open To All Commercial Enterprises:

Any legitimate commercial entity (profit or non profit) that is invited by ProVision Corporation to participate in the Collective will be allowed to be a cost and risk free Associate of the Collective. ProVision Corporation treats ALL Associates -- regardless of size -- equally. All Associates shall have equal access to all the ProVision Corporation benefits and services for which they are qualified.

No Liability:

No Associate, or individual associated with any organization that is an Associate, shall have any liability, responsibility or culpability to or for any of the debts or obligations of the ProVision Corporation or any Associate of the Collective. Likewise, ProVision Corporation shall have no liability for the debts or obligations of their Associates.

No Cost or Fees Ever:

There shall NEVER be any payment of dues or fees for the privileges and assistance offered to the Associates by ProVision Corporation. It is free of cost or obligation to all Associates. The ProVision Corporation Collective is funded through service providers who are referred by ProVision Corporation and chosen by the Associate because it WILL lower their overhead. It is based totally on performance, and paid by the service provider.

No Ownership Stake:

Associates are not shareholders or partners or owners of the ProVision Corporation entity.

Benefits of Being An Associate:

ProVision Corporation acts as an advocate for its Associates, and has pledged to look out for their best interests. Associates may qualify for access to: experts who can assist them in becoming more efficient in their operations and who can find and recover money from past oversights, inefficiencies or inaccuracies; and have access to elite service provider relationships that Associates may not have been qualified for if they were not associated with ProVision Corporation. Other benefits, from time to time, shall be made available to all qualified Associates as they are negotiated by ProVision Corporation through the collective volume and influence that the ProVision Corporation Collective represents.

ProVision Corporation As An Advocate:

ProVision Corporation needs data in order to assess the needs of the Associate. All information submitted to ProVision Corporation shall be received under a pledge of strict mutual confidentiality. The Associate shall have all the advantages of the Collective's bargaining power so long as the Associate is willing to help ProVision Corporation in its ability to assess the needs of the Associate, and its operation. If, in the opinion of ProVision Corporation, there is a need for

efficiency, recovery expertise, or a better service provider to be made available to the Associate on a pure contingency basis, then ProVision Corporation, at no cost or risk to the Associate, shall use the power of its collective volume and strong relationships with top level and very reputable service providers to make a risk free referral for assistance to the Associate. Quality References and a confidentiality agreement shall be offered by the service provider, efficiency expert, or analyst referred by ProVision Corporation and provided to the Associate for the Associate's approval. The Associate always makes the ultimate decision to engage or not engage the services of the referred service providers. No Obligation:

There is no duty (express or implied) on the part of the Associate to follow the advice of ProVision Corporation, or to exercise the Associate's right to take advantage of any service offered. ALL decisions involving the business interests of the Associate are totally and completely made by the Associate with no obligation to ProVision Corporation for the Associate to do what ProVision Corporation suggests. ProVision Corporation shall have NO authority to make decisions for the Associate.

Strict Pledge of Confidentiality:

ProVision Corporation pledges that the information it receives from its Associates is not sold to businesses seeking to advertise to or otherwise solicit them. All information received is held as strictly confidential and is only provided to ProVision Corporation experts or service providers with the sole intention of helping the business save or recover money. The Associate shall not appear on lists used for any commercial purpose.

Termination of Relationship:

ProVision Corporation reserves the right to cease its efforts as an Advocate for the Associate if and when the Associate is not willing to accommodate reasonable requests for information in order to assess the needs of the Associate that are necessary to facilitate ProVision Corporation's duty to make recommendations on behalf of the Associate. The Associate always has the right to not follow the recommendations of ProVision Corporation. Not cooperating with the reasonable need for information to assess the needs of the Associate and deliver solutions could be reason to cancel continued assistance.
